

Hell's Pharmacy Joseph Herrin (08-14-09)



In writing this post I have experienced a greater horror at the discovery of the sinister abominations coming forth upon the world than I can remember. It was as if my spirit man were weeping at the things being revealed. If you had any doubts about whether you were to take the upcoming swine flu shot, or any other type of vaccination, you need to read this post.

As I have been following the news about the hyped flu pandemic, it has become evident that there is an evil and malignant power behind it all. Satan is “the god of this world” (II Corinthians 4:4), and he has many evil men who would gladly follow him as he offers them that same temptation that Christ turned down. Satan offers to them the kingdoms of this world if they will only bow down and worship him.

Many men have done so willingly, and multitudes more follow out of deception, not knowing who it is they are serving. These men (and women) are found in government, industry, and in positions of religious influence. Some of them work in the Pharmaceutical industry, and they are bringing forth greater sorceries upon the earth than has ever been seen before.

In the New Testament we find that the Greek word translated into the English word “sorcery” is *pharmakeia*. In Revelation, John describes Babylon the Great, the Mother of Harlots, with the following words:

Revelation 18:23

Your merchants were the great men of the earth, because all the nations were deceived by your *sorcery*.

This verse literally says that the merchants of Babylon were the great men of the earth, and “all the nations were deceived by your pharmakeia.” The related word “pharmakeus” described one who was “a druggist, a poisoner, a magician” (Source: Strong’s Concordance of the Bible).

At this very moment there is being planned a great illusion. It will be the act of the great deceiver who deceives all the earth. He is about to bring millions, perhaps billions, of people to practice child sacrifice and abominations without their knowledge. What is coming is truly diabolical.

I have read media reports and have understood that it usually takes 6 to 9 months to develop a flu vaccine AFTER the flu strain has been identified. The traditional process is to inject viral material into chicken eggs and then to harvest the antibodies that are produced. This is a time intensive process, and a way to speed up the production of vaccine has been sought, and has been found.

The foremost way to streamline the process involves taking human cells, instead of eggs, and using them as the medium in which to grow the viral material to produce the desired vaccine. In looking into this new process, I found that one company in particular has a line of cellular material that they license to other major pharmaceutical companies so that they can create pharmaceutical products. These products include flu vaccines.

The company is called Crucell. It actually has multiple lines of human cell material, but one in particular, called PER.C6, is marketed to be used to develop vaccines. What the company does not announce publicly is that the cell line was derived from an aborted baby.



PER.C6 cells are derived from embryonic retina cells of aborted fetuses. These cells taken from the eye of a baby aborted in 1972 and frozen. In 1985 they were unfrozen and used to start this cell line. This aborted baby's cells have been reproduced and distributed to other pharmaceutical companies to be injected into millions of people's bodies.

This cell line is pronounced as "Percy Six." According to the website www.behindthename.com, the name Percy came from a Gaulish (French) name that was Latinized as Persius. This name sounds much like Percy Six. Looking at the meaning of the name Perseus one discovers another omen of this product's evil.

The United States Food and Drug Administration is aware of the source of this cell line. In 2001 the FDA held meetings at which testimony was given concerning PER.C6.

MEETING WEDNESDAY, MAY 16, 2001

We will now call on Dr. Alex van der Eb to tell us about adenovirus transformation of human cells and the development of 293 and PER.C6 cells for the manufacture of defective adenovirus vaccines.

Dr. Alex Van Der Eb, of Crucell is speaking...

So what I would like to do is to describe to you how and why we have made two different cell lines, adenovirus transformed human embryo cell lines

which are called 293 and PER.C6. Both cell lines were made in my lab, and also the cells, the starting material, was prepared by myself at the University of Leiden. The 293 cell was made by Frank Graham in 1973 from human embryonic kidney cells that were made from fetal tissue one year ago..., whereas the PER.C6 cell was made by Ron Bout and Frits Fallaux in 1995 from an embryonic retina cultures that were made from fetal tissue by me ten years before that, in 1985...

So in 1995, Brahm Bout (phonetic), Frits Fallaux, Brahm Bout from IntroGene and Frits Fallaux from our university Gene Therapy Group, decided that we should try and make a new helper cell line... And indeed, in order to make a new system that allowed pharmaceutical production of adenovirus vectors.... It should also meet pharmaceutical standards. If you start all over again you can just as well try to do that, and it could be the basis for the manufacture of multiply deleted Adenovirus 5 vectors also. So we chose the human embryonic retina cells at that time...

So I isolated retina from a fetus, from a healthy fetus as far as could be seen, of 18 weeks old. There was nothing special with a family history or the pregnancy was completely normal up to the 18 weeks, and it turned out to be a socially indicated abortus - abortus provocatus, and that was simply because the woman wanted to get rid of the fetus.

We got this. There was permission, etcetera, and that was, however, was in 1985, ten years before this...

"The father was not known, not to the hospital anymore, what was written down was an unknown father, and that was, in fact, the reason why the abortion was requested."

This company acquired the body of a baby aborted at 18 weeks (6+6+6). It took cells from the eye of the child, and has used them to develop a line of cellular material that it is deriving great profit from. Unknown to millions of people, they are being injected with biological material taken from a healthy child that was killed in what is described as "a socially indicated abortus." That is to say, it was an unwanted pregnancy taken from a sexually immoral woman

who did not even know who the father was.

Crucell states on their website that the PER.C6 cell line has been marketed to other pharmaceutical companies and has been used in a number of vaccines. According to the company's website, "*PER.C6® technology is being used in Crucell's programs for the development of vaccines against tuberculosis, malaria, influenza, Ebola and Marburg.*" Added to this list is now H1N1 swine flu vaccine.

In looking at Crucell's website, I was struck by the symbolism of their company logo.



Not only does this "eye" logo relate to the retinal tissue of the aborted baby that is used for their PER.C6 product line, it also is a symbol of the Illuminati, the Freemasons, and many other Luciferian organizations. The all seeing eye, a single eye, is a well documented symbol of occult organizations.



On Crucell's homepage they also have displayed a graphic that once more draws attention to the eye of a child. Just one eye is shown, and the same symbolism and references are once more brought into focus.

It is sickening to consider that someone is making a macabre joke in focusing on the eye of a small black child. In America the percentage of abortions broken down by race reveals that a disproportionate number of abortions are performed on blacks. Planned Parenthood places most of their clinics in minority neighborhoods, and Margaret Sanger, the founder of the organization openly promoted Eugenics. Eugenics was a pseudo-science focused upon selective breeding and the removal of undesirable elements from society. For those who view whites as a superior race, it seems prudent to them to take steps to insure that other races are suppressed.


According to the Alan Guttmacher Institute, more than 43 percent of African-American pregnancies end in abortion. Although African-Americans represent only 12 percent of the American population, they account for almost 35 percent of all abortions. In Mississippi, for example, while African-Americans represent only 37 percent of the population, they account for 73 percent of the state's abortions. More than 78 percent of Planned Parenthood's abortion centers are in or near minority communities.

Look again at the graphic for Crucell. It seems possible, even probable, that Satan is mocking both God and man by focusing attention on the eye of a child on Crucell's home page. This is macabre and sinister. To harvest the eye cells of an aborted baby and then inject them into millions, or even billions of people is nothing other than a re-enactment of the ancient and perversely cruel rites of Baal and Moloch worship where children were sacrificed to bring blessing to the rest of the population.

A question that many should want answered is “Are the vaccines the government will encourage, or even force, its citizens to take derived from the cells of an aborted baby? Searching the Internet the answer appears to be “Yes!” Using haste as a rationale, Pharmaceutical companies are abandoning the egg as a traditional medium, and they are using cell lines instead. Unlike food products that are required to show clearly their ingredients, the FDA does not require Pharmaceutical companies to tell what is in their vaccines.

Even if the companies declared that they did not use fetal material, I would not trust them. Baxter was recently caught shipping live Avian flu virus to labs in Europe that were not to contain any such thing. The particular strain of virus Baxter sent out is fatal in 60% of the people who contract it. Did the vaccine contain a label declaring that it contained live Avian Flu virus? The company claimed it was a mistake. Would you trust this same organization to not use fetal material in the development of their vaccines?

If these same mega-corporations say they did not use fetal material, are we

merely to take their word? Yet, many of them do not even deny using these cell lines in their products. According to a Crucell press release:

Crucell develops vaccines and licenses its PER.C6(TM) cell line technology to companies in the pharmaceutical and biotechnology industry. The company's licensees include Merck & Co. for its HIV vaccine, Novartis, GSK, Centocor/J&J and Aventis. Crucell has partnered with the US National Institutes of Health (NIH) for the development of an Ebola vaccine.

Listed among Crucell's customers for its PER.C6 cell line are some of the world's largest drug makers. One of them is Sanofi Pasteur. According to their website, they are using the PER.C6 cell line for their swine flu vaccine, and the United States Department of Health and Human Services has awarded them a contract.

It is doubtful that the U.S. will identify what company they obtained the particular vaccine from that they wish to inject individuals with, nor will they reveal how it was made. The U.S. government recently contracted with Novartis to deliver \$289 million dollars worth of flu vaccine. Novartis declares on their website that they are using cell-based technology to speed up the process, instead of the older egg based technology. It seems significant as well that Novartis is manufacturing the vaccine at its Holly Springs, North Carolina facility.

Novartis states that they are using a “proprietary cell line,” but they have not disclosed the origin of it. Seeing that they have contracted previously with Crucell to use their PER.C6 cell line, I do not trust them to disclose truthfully the origin of the mammalian material they are using. According to Crucell’s website, Novartis contracted with them to use PER.C6 in December, 2004. Can you imagine the triumph of Satan as he gloats over how he has induced millions of men, women and children to receive into their bodies biological material taken from the retina of an aborted child? Like the pagan practitioners of old, he has convinced them that the sacrifice of a child will result in their good, it will insure their welfare.

It is not hyperbole, sensationalism, or exaggeration to suggest that the world's largest pharmaceutical companies are using body parts from babies to develop their vaccines. They are then injecting these vaccines that contain the infant's DNA into millions of men, women and children, telling them that it will be of great benefit to them.

it was shown that a number of suppliers of Swine Flu vaccine who are under contract to the World Health Organization and the United States government, are developing their vaccines using cell lines developed from aborted babies. In particular, the company Crucell and their cell line PER.C6 were examined. As I have looked further into this subject I have found that this is not a new practice, and to the horror of many, they may discover in this writing that they, or their children, have already received vaccines that were developed from the cells of aborted babies.

In part one of this series I stated that the actions of these companies is sinister

and macabre. A standard English dictionary defines the word *macabre* as:

Macabre: gruesome and horrifying; ghastly; horrible; of, pertaining to, dealing with, or representing death, especially its grimmer or uglier aspect.

In the year 1729, Jonathan Swift wrote a satirical essay titled, “A Modest Proposal.” The subtitle read, “For Preventing the Children of Poor People in Ireland from Being a Burden to Their Parents or Country, and for Making Them Beneficial to the Public.”

What Jonathan Swift proposed in this writing is that the impoverished Irish population might ease their suffering by selling their children to the nobility and the rich. What would the nobility and rich do with these children? They would eat them.

Swift’s writing has a shock value because it begins as a very serious piece, describing the impoverished conditions of the poor in Ireland. Then, out of the blue, he suggests his solution to this social dilemma. “A young healthy child well nursed, is, at a year old, a most delicious nourishing and wholesome food, whether stewed, roasted, baked, or boiled; and I make no doubt that it will equally serve in a fricassee, or a ragout.”

One deceit used by Swift to make his macabre proposal sound reasonable, is to describe the Irish infants using the language of animal husbandry. In doing so, he makes them appear less than human.

Once the children have been commoditized, Swift’s rhetoric can easily turn “people into animals, then meat, and from meat, logically, into tonnage worth a price per pound.”

What Jonathan Swift did in a work of fiction, America, her government, the medical community, and pharmaceutical corporations have done in reality. They have for years labored to describe a baby in the womb as less than human. John Holdren, an appointee of President Barack Obama, in a book titled *Human Ecology, Problems and Solutions*, made the following shocking statement:

“The fetus, given the opportunity to develop properly before birth, and given the essential early socializing experiences and sufficient

nourishing food during the crucial early years after birth, will ultimately develop into a human being.”

People of God, Jonathan Swift may well have used the same title for his satirical work as John Holdren, *Human Ecology, Problems and Solutions*. Shockingly, however, John Holdren’s work was not intended as satire. He was being absolutely serious. The book from which this quote was taken was published the same year that Roe v. Wade became the law of the land. Like the Supreme Court, Holdren used language to describe the unborn baby as less than human, calling it “the fetus.”

God declares the baby growing in the womb to be much more than a medical pseudonym for a piece of tissue.

Psalms 139:13

For You did form my inward parts; You did weave me in my mother's womb.

Isaiah 44:2

Thus says Yahweh who made you and formed you from the womb, who will help you...

Jeremiah 1:5

Before I formed you in the womb I knew you, and before you were born I consecrated you...

Yahweh, the God of all creation, declares that He knows the person from the very time in which they are being formed in the womb. Before we are fully formed, He declares that He knows us. Yet man, in his perversity, has described the child growing in the womb as less than human. Barack Obama’s TOP science advisor has written and published his own view that a baby will ultimately become a human being if it is given the chance to develop normally in the womb and is then provided years of proper socialization and nourishment.

I can tell you clearly where such reasoning leads, right back to the atrocities committed by Nazi Germany. Note that John Holdren does not say that a baby becomes a human being at a certain age. He says that it must be socialized properly to be categorized as a human being. This leads directly to the ultimate result that some men, women and children will be declared less than human if they do not pass the governmental test for proper socialization. If you or I

believe, or behave in a manner, contrary to what the government declares to be proper social behavior, we will fall into the category of being sub-human. If you are not human, then it is not murder to kill you.

Do you think this logic sounds extreme? It is the same logic that has been used to justify the slaughter of over 50 million babies in America during the last 36 years. By declaring them less than human, the government has declared it to not be a criminal act to murder a baby while it is in its mother's womb. For much of this time, they have even declared that it is not murder to kill a baby after it exits the womb, as long as the head has not been fully withdrawn. (Or in the case of a breech birth, the baby has not exited the womb further than its navel) This has led to the horrific practice of partial birth abortion, a form of abortion that Barack Obama supports.

Congress twice sought to ban this type of abortion, passing laws against it in 1995 and 1997, but President Clinton vetoed the legislation both times. In 2003 the Supreme Court upheld a ban on the procedure based on the argument that *"A moral, medical, and ethical consensus exists that the practice of performing a partial-birth abortion... is a gruesome and inhumane procedure that is never medically necessary and should be prohibited."* However, there are loopholes in their ruling, and with new appointments to the Supreme Court it is only a matter of time before even this *"gruesome and inhumane"* procedure is once more permissible as the law of the land.

By referring to the baby with the scientific terminology, those favoring abortion have employed the same tactics used by Jonathan Swift in *A Modest Proposal*. They have given people reason to view a child in the womb as something other than a human being. Jonathan Swift suggested that Irish infants should be viewed as merely animals to be harvested for their meat. The government, scientific community, abortion proponents, and medical and pharmaceutical industry have described infants as merely biological tissue and have thereby dehumanized them.

We see now that Barack Obama has given top appointments to those who would go even further in suggesting that a child is not even human after it has been born. It must be properly nourished and socialized for years before being determined to be human. The abominations this type of reasoning will lead to will be seen in the near future.

It is this same perverse and macabre logic that has led to the government

awarding contracts worth hundreds of millions of dollars to pharmaceutical companies to develop vaccines that are derived from the organs and cells of aborted babies. In many cases the government has already demonstrated that they will not shrink from declaring such vaccines mandatory. They have been mandatory for years in order for children to attend the public school systems. The following excerpt is taken from the website of the national Right To Life organization.

Cell Lines Originating from Aborted Babies

There are two particular fetal cell lines that have been heavily used in vaccine development. They are named according to the laboratory facilities where they were developed. One cell line is known as WI-38, developed at the Wistar Institute in Philadelphia, PA. The other is MRC-5, developed for the Medical Research Council in England. WI-38 was developed by Dr. Leonard Hayflick in 1962, by taking lung cells from an aborted female baby at approximately the end of the third month of pregnancy.

Dr. Hayflick's article published in the scientific journal, Experimental Cell Research states that three cell lines, WI-26, WI-38, WI-44 were all developed from aborted babies. "All embryos were obtained from surgical abortions and were of approximately three months' gestation." In another journal article (American Journal of Diseases of Childhood) from an international conference on Rubella, Dr. Stanley Plotkin who developed a Rubella vaccine using WI-38, addressed a question as to the origin of WI-38.

Dr. Plotkin stated, "This fetus was chosen by Dr. Sven Gard, specifically for this purpose. Both parents are known, and unfortunately for the story, they are married to each other, still alive and well, and living in Stockholm, presumably. The abortion was done because they felt they had too many children. There were no familial diseases in the history of either parent, and no history of cancer specifically in the families."

The origin of the MCR-5 cell line, created in 1966, is documented in an article in the journal Nature by three British researchers working at the National Institute for Medical Research. J.P. Jacobs, et. al. write, "We have developed another strain of cells, also derived from foetal lung tissue, taken from a 14-week male foetus removed for psychiatric reasons from a 27 year old woman with a genetically normal family

history and no sign of neoplastic disease both at abortion and for at least three years afterward...”

In both of these cell lines it is quite clear that the aborted children were presumed to be healthy, and that there was no life-threatening condition or other medically indicated reason for the abortion of these two babies...

The article goes on to provide a list of vaccines that have been in use for years that utilize these cell lines developed from aborted babies.

The website goes on to mention that President George W. Bush ordered that America procure a supply of Smallpox vaccine in the event of a bioterrorist attack. No cases of Smallpox have been identified anywhere in the world since 1977. However, both the USA and Russia maintain live Smallpox virus which

could be weaponized and used to begin the spread of the highly contagious, and often fatal disease. The Smallpox vaccine procured by the United States, in part was derived from aborted fetal cell lines.

It is a sick and sinister world that we live in. I can foresee the hour quickly approaching when some highly contagious plague is loosed upon mankind, and the proffered solution is to receive a mandatory vaccination that is derived from the cells of an aborted baby. Those who will object in the greatest measure will be Christians, and they will be vilified as radical religious extremists. Their refusal to take the mandatory vaccine will be viewed as detrimental to society. They will in many cases be rounded up and held in regional detention centers to effectively be quarantined.

The medical and scientific community has lost all sense of humanity. They have changed the language in which they describe human life to something devoid of personality. In doing so they have dehumanized mankind.

Science and the medical industry is on a course that views life in the womb as no more than a biological factory from which they might extract the material to meet their scientific and health goals. Progressively, human life from embryos to full-term babies are viewed as medical storehouses where cellular material can be harvested. Dr. Bernard Nathanson, creator of the pro-life films *Silent Scream* and *Eclipse of Reason*, stated the following:


“There are 1.4 million insulin dependent people in the United States and 30,000 new cases every year. To treat them, eight fetal pancreases are needed per person, harvested at 14 to 20 weeks and the prostaglandin abortion method must be used to preserve the pancreas. That equates to roughly 12 million fetuses at 14 to 20 weeks. With a total of 1.6 million abortions done annually in the US, where are all these babies, in that specific gestational age going to come from? Additionally there are four million people in the United States with Alzheimer’s Disease and 250,000 new cases every year. It takes five fetuses at 9-12 weeks to supply enough tissue to treat a central nervous system disease for one person, but there are also paraplegics, cerebral palsy sufferers and stroke victims. We would need 2.5 million fetuses at 9 to 12 weeks per year at least. Currently there are 800,000 babies a year killed in this 9 to 12 week window. Where are the other 1.7 million going to come from?”

Some are advocating that human cloning is the answer to provide the necessary

biological material. By cloning, limbs and organs, bone marrow, blood cells and all manner of biological material might be created for the express purpose of being harvested to be implanted in people who can afford the procedures. Such a plan is perverse and an abomination in the eyes of God.

One of President Obama's first acts as President involved expanding the research and development of embryonic stem cell lines. Such research again views human life as little more than a biological chemistry set.

The Lutheran Church has already allowed the nation's largest abortion provider to serve as clergy, now they are voting on whether to allow homosexuals to do the same. Hell's Pharmacy - Part Three Joseph Herrin (09-11-09)



I want to call your attention to an absurdity of staggering dimensions. I want to draw your focus to a startling abnormality. There is something so out of skew, so overemphasized and prevalent in American society today (and in all other nations who conform to the same pattern), that a rational man who is unaccustomed to it would immediately be alarmed. Yet this aspect of our society is so ubiquitous, and it has been present for such a length of time, that most people do not even notice it, though it is all around them.

What I am speaking of is America's dependence upon, addiction to, and appetite for, drugs, pills, or pharmaceutical products. Consider for a moment how many drug stores there are in any city in America. Any town of at least 10,000 citizens is bound to have several drug stores, such as Walgreens, CVS, Rite Aid, Eckerd's, Rexall, etc.. Then there are the department stores and grocery stores that sell drugs, many of which have in-house pharmacies that are fully staffed.



The website www.drugs.com provides information on more than 24,000 prescription and over-the-counter drugs. Government statistics from the year 2004 show that more than 91% of seniors in America rely upon prescription drugs, while 61% of non-elderly adults take one or more prescription medications. These numbers are bound to be higher now that Medicaid is paying for prescription medications. Government statistics show that Americans spent over \$200 billion dollars on prescriptions in the year 2005.

Pharmaceutical companies are the most profitable in the world. One of the reasons for this is that there is no real relationship between the cost of a prescription drug and the cost of manufacturing. The policy for setting drug prices is “whatever the market will bear.” People are more willing to pay exorbitant amounts of money for drugs they are convinced by their doctors are necessary for their continued life and health, than for non-essentials, and the drug companies have capitalized on this knowledge. In 2002 a report came out relating the cost of certain prescription drugs to the actual value of their ingredients. Following are some examples.

Of course, these figures do not take into account the typical business expenses involved with such products, such as research and development, advertising, packaging and distribution, but even with these expenses factored in the profits generated by these drug companies are obscene.

It should be noted, that one glaring absence from President Obama's Health Care Reform Bill is any attempt by the government to attain a cost savings in purchasing prescription drugs. From the inception of this bill it has been announced that the government will NOT seek to bargain with the pharmaceutical companies for a better price.

It is also interesting to note that at a time just prior to the American economy taking a sharp downturn, President George W. Bush successfully pushed for changes to be made in Medicaid that included paying for prescription drugs. When people have less money, they pare their spending, and many end up choosing between food and drugs. Consequently, a certain percentage will buy less drugs. The government is controlled by a global elite who have a great interest in keeping people using drugs, even when the economy takes a downturn.

Is it not peculiar that a President from the Republican party, a party known for its platform of "less government" and free market capitalism, would, at a time when the budget was encountering vast deficits year after year, push forth the largest increase of government social spending in decades?

On December 8, 2003 President Bush signed the Medicare (Prescription Drug Act) into law... Weeks after the signing, the White House's 2004 budget request estimated the price of the Act at over \$540 billion.

Thus, at its inception, the government budgeted an amount equivalent to \$1,800 for every man, woman and child in America. This money was to go directly to the pockets of the pharmaceutical companies. Beyond any question

in my mind, there is tremendous financial corruption present in these activities. Yet the ultimate agenda behind getting a majority of the population dependent upon prescription medications, then positioning the government as the dispenser of these drugs, is *control*.

In 1961 Ronald Reagan made the following statement in a speech.

"One of the traditional methods of imposing statism, or socialism, on a people has been by way of medicine. It's very easy to disguise a medical program as a humanitarian project. Most people are a little reluctant to oppose anything that suggests medical care for people who possibly can't afford it." - Ronald Reagan

Rick Joyner, the head of Morningstar Ministries, in a recent Special Bulletin commenting on President Obama's massive new Health Care Reform Bill, stated:

It is beyond anything I thought I would ever see in my lifetime that such a bill could ever be seriously considered in the U.S. Congress. This bill has the potential for totalitarian control to be imposed on America to a degree that Hitler and Stalin could not have even imagined. With the technology available now, totalitarian control can very quickly be imposed to a degree far beyond what was attained by either the Nazis or the Communists, and this bill has provisions in it for just that. It mandates the sharing of all of your personal information, from just about every conceivable source, with the new health care bureaucracy being set up to implement this national health care system. The penalties for trying to escape this web are serious. This would actually make America into a national concentration camp, and we can be sure that ultimately it will be a national death camp...

In the early 1990s, myself and a few other prophetic friends were all shown separately, but at the same general time, that the same evil that gained access to Germany in the 1930s was going to seek access to America. I have shared this often since then, and have made many trips to Germany to seek to understand what happened there. Col. Eugene Bird became one of my dearest friends, and I spent many days with him listening to what he had learned about this, which was considerable. Col. Bird was the U.S. Commandant of the Spandau Prison that held the Nazi war criminals, and ultimately became the one many considered to be the foremost authority on Nazi Germany. Bird's insight into how evil can gain entry into the human soul and into

governments was remarkable, but I always had trouble seeing a connection that would allow what happened there to actually happen in America. Bird often chastised me for this, warning that it could easily happen in America (Col. Bird lived most of his life in Germany, where he became loved and esteemed by that nation, but he remained a patriotic American to the end). Bird often explained how the evil spirit of death that took over Germany gained entry through its health care system. Now it is easy to see what he was talking about in what is being proposed by the Obama Administration.

There are a wealth of resources on the topic of America's prescription drug obsession. Corporate advertising, the medical profession, and government form three sides of a pyramid that all work together to drive the population to a drug dependent state.

Those who live in America are so immersed in a pharmaceutical culture that they are led to think such a dependency is normal and beneficial. Drive down the road and you will see drug stores in abundance. Go into Walmart, or your favorite grocery store, and there is a pharmacy and a section for over-the-

counter drugs. Turn on the television, or open a magazine, and there are an abundance of ads for every conceivable type of drug. If you have a problem, the drug companies offer a solution.

Can't sleep at night, take Ambien, Lunesta, or Sonata.

If your child has too much energy at school and will not settle down, give him/her Ritalin, Concerta, Adderall, Vyvanse, or Focalin.

Are you depressed, anxious, or worried, there is Prozac, Lexapro, Effexor, Paxil, or Cymbalta.

With more than 24,000 drugs listed in the *Physician's Desk Reference*, such a list of problems and designer drug solutions could go on for hundreds of pages. Most drugs do little to address the cause of a problem. They only deal with symptoms, and the side effects can be much more serious than the original problem.

Christians are citizens of the Kingdom of God. As such, they should not adopt the ways and methods of the world. Christians are called to be aliens and strangers in this world. They have one who is the Great Physician who can reveal to them the root of a problem, and prescribe a true solution.

Yes, God will at times use physicians and drugs to heal His children. I do not deny this, nor am I seeking to create a general doctrine that says all medicine and medical practice is evil. II Chronicles 16:7-13

At that time Hanani the seer came to Asa king of Judah and said to him, "Because you have relied on the king of Aram and have not relied on Yahweh your God, therefore the army of the king of Aram has escaped out of your hand. Were not the Ethiopians and the Lubim an immense army with very many chariots and horsemen? Yet, because you relied on Yahweh, He delivered them into your hand. For the eyes of Yahweh move to and fro throughout the earth that He may strongly support those whose heart is completely His. You have acted foolishly in this..."

Having fallen into a pattern of unbelief, failing to seek God for his needs, Asa later became diseased in his feet and turned to the doctors rather than to Yahweh.
